**2024 Year-End Narcotics Seizures and Purchases**

For the year ending **DECEMBER 31, 2024**, the PBDTF seized and purchased narcotics totaling **\$1,035,077**:

- A combined total of **10,613 grams (23 pounds) of Methamphetamine**, having a street value of **\$658,006**
- A combined total of **2,024 grams (4.4 pounds) of Heroin/Fentanyl**, having a street value of **\$273,240**
- A combined total of **491 Fentanyl Pills**, having a street value of **\$7,856**
- A combined total of **829 grams (1.8 pounds) of Psilocybin Mushrooms**, having a street value of **\$29,015**
- A combined total of **744 grams (1.6 pounds) of Cocaine**, having a street value of **\$66,960**
- A combined total of **588 Pills**, having an unknown street value
